05.10.2020

Welcome to Partners and approval of the program

The meeting started on **05.10.2020** with the speeches of faculty members of The Barcelona University as representatives of the host partner institution.

Evaluation of work since the University of South Bohemia, Czech Republic meeting

Task assignments done from the beginning of the project was reviewed. Systematic review which had contributions of all partners, was evaluated and decided to be ready for publication. Current status of the content of the education program that has been developed was evaluated once again. BENEFITS

tool which was to be developed to assess the students within the project was discussed and the current progress was evaluated.

Transcultural Nursing Education in Barcelona University, Spain

Our partner from Barcelona shared their experience on transcultural nursing education. Questions were raised especially on implementation methodology and evaluation criteria of the transcultural nursing education system. Particularly, peer-assessment, case discussion and active learning methods and technology used by students were noteworthy.

Transcultural Nursing Education in the Erasmus Hogeschool, Belgium

Participants from our Belgium partner shared detailed information on transcultural nursing education methods and content in Erasmus Hogeschool. Especially, invitation of guest lecturers from different cultural backgrounds, having the classes in English and utilizing an effective online training environment were noteworthy. Additional questions of the partners and experience sharing enriched the evaluation of the training methods.

Transcultural Nursing Education in the Debrecen University, Hungary

Our colleague from our Hungary partner shared detailed information on transcultural nursing education methods and content in Debrecen University. Transcultural nursing education was not a single class or program. Instead it was dealt in several classes integrated in different classes and programs. It was suggested that nursing education should be promoted with a cultural perspective.

Discussion about the BENEFITS tool for the student. Sharing of tasks related to tool development survey

A question pool was developed for BENEFITS tool and all partners reviewed it online. At the meeting, it was once again reviewed by the participants and decided to be structured as Likert type (Likert with 7 options). Also, our studies linked with the project were reviewed once again by the participants with the leadership of our partners from University of South Bohemia.

06.10.2020

Quality management and quality report of the project until September 2020

The results of the survey done for quality management was presented to the quality management committee. Weak and strong aspects were discussed. Ongoing process of the quality management plan reviewed.

Discussion about the BENEFITS Course Content and Suggestions.

Ten-minute presentations of all partners were shared with participants and suggestions for content were discussed. Subjects, sub-headings, education methods, evaluation methods were discussed. Partners from University of Barcelona and Erasmus Hogeschool who had more experience in transcultural nursing education were assigned to collect the suggestions of the partners and develop the course program.

Development of a Workplan for the Coming Meetings and education program

There were concerns on our next transnational project meeting and intensive training program to have them face to face due to the COVID-19 Pandemic. Next transnational project meeting that was to be done in March 2021 at HKU in Turkey was decided to be postponed and executed in May 2021 at HKU in Turkey. Also, it was decided to have the intensive training program in August 2021 at Debrecen University in Hungary instead of May 2021 at Erasmus Hogeschool in Belgium. It was decided to inform the National Agency and have their approval to make changes in the project execution program. All question of the coordinator and the partners were answered mutually to make everything crystal clear. The decisions taken during the meeting were inspected once again before the conclusion.
